2027 ADMISSIONS CRITERIA

Placement is done **STRICTLY** according to the Admissions Criteria and subject to the availability of space.

Completing and submitting an Application Form does NOT guarantee placement at AMPS.

IMPORTANT: DO NOT remove your child from their current school unless you have received written confirmation of acceptance from AMPS (Placement of successful applicants will commence in the 4th term of 2026).

- **INCOMPLETE OR DISHONEST** information will make your application “NULL AND VOID”.
- **ONLY** Biological parents OR Legal Guardians can apply for possible enrolment at AMPS.
- Aston Manor Primary School is a Section 21 Fee Paying Public School
- The completed Application Form and ALL the required documents can be handed in at the office during office hours (07:15 – 14:00) OR emailed to Admissions@amps.za.com

Admission Criteria:

WAITING LIST 1:	Home address within School Feeder Zone: Learners and Biological parents / Legal Guardians must reside within the feeder zone of the school. (<i>Nimrod Park, Aston Manor, Glen Marais and parts of Allen Grove</i>) Distance from the school does not apply for WL1.
WAITING LIST 2:	Siblings: Learners with a biological sibling in AMPS (Gr. 1 – 6) and resides in the same house as these siblings.
WAITING LIST 3:	Work Address within School Feeder Zone: Learners whose biological parent/s are employed at an address within the feeder zone of the school.
WAITING LIST 4:	Home Address within 30 kilometres of the school: Learners not residing inside the feeder zone of the school, but within a 30 kilometres radius from this school.
WAITING LIST 5:	Home address of learners beyond 30 kilometres from the school: Learners who resides beyond 30 kilometres from this school.

Admission Requirements:

NB: Required documents may **not be older than three (3) months and must be certified. NO AFFIDAVITS.**

Information for **BOTH biological parents** are required – even if you are not living together.

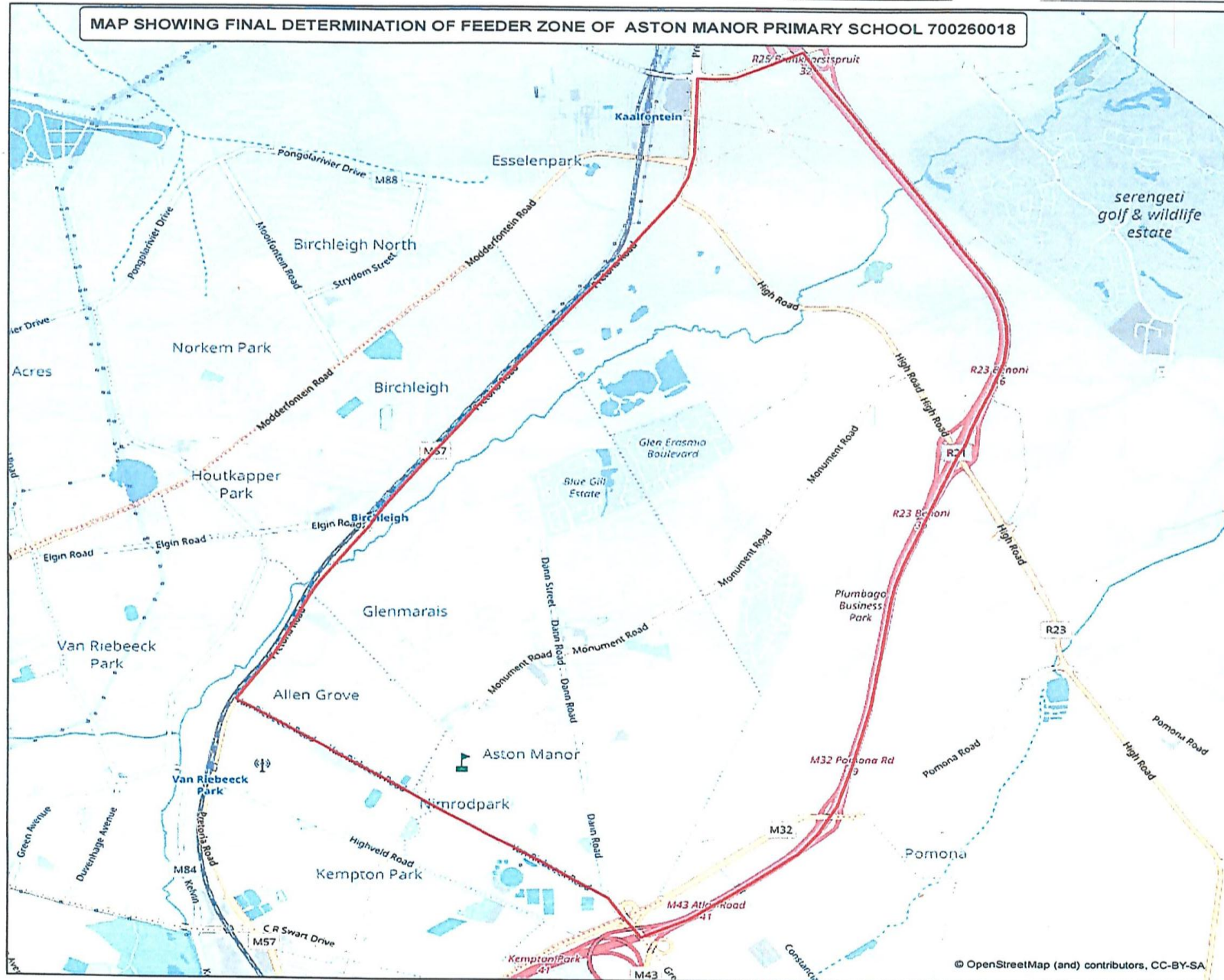
#	<u>Required Document</u>	<u>Document Description</u>
1	Unabridged Birth Certificate	Names of both biological parents should reflect on the learners Unabridged Birth Certificate .
2	ID document	Identity documents of both biological parents , as recorded on the Unabridged Birth Certificate. • Copy of Death Certificate is required, if one of the biological parents are deceased.
3	ID Photos	Two (2) recent ID photos (actual id photos) of the learner – only if your application is successful .
4	Report Card	Most recent Report Card from the learner’s current school or crèche. • Name of current school and date on report card MUST be visible.
5	Clinic / Immunization Card	Name of the child, date of birth, parent’s names and all immunizations must be visible.
6	Residential Address	For Homeowners: Municipal account / Utility Bill not older than 3 months in the name of the biological parent of the applicant, bearing full residential address. For Tenants Renting Property: (ALL of the items listed below MUST be provided) • Full Lease Agreement signed by the landlord and tenant, reflecting the names of all the tenants AND bearing the full residential address. • AND the Municipal account / Utility bill from the landlord (homeowner) not older than 3 months bearing the full residential address rented by the biological parents of the applicant. • AND an ID Copy of the landlord as per the municipal account / utility bill. (if possible) • AND Rental Payment receipts reflecting the full residential address for 3 months. • AND a Statement of any other account (NO Bank Statements) in the name of the biological parents of the applicant, bearing the full residential address.
7	Work Address: If you are applying using your work address	Formal letter from your HR department , on a company letterhead confirming your work address, AND proof of your residential address as per above, must be provided.
8	Legal Guardianship Documents	If the child does not live with the parents, LEGAL Guardianship documentation (<i>from the Court</i>) proving Guardianship, must be provided together with the ID documents of the legal guardians.
9	Foreign Nationals	If you are a Foreign National, we require the • Parents Passport and Work and/or Residency Visa as well as the Passport and Study Visa for your CHILD. Letters will NOT be provided to apply for Study Visa’s.
